## ISO 15926 Integration of life-cycle data for process plants including oil and gas production facilities



- ISO 15926 1: Overview and fundamental principles (2004)

- ISO/TS 15926 3: Reference data for geometry and topology (2009)
- ISO/TS 15926 4: Initial reference data (2007)
- ISO/TS 15926 6: Methodology for the development and validation of reference data (2013)
- ISO 15926/TS 7: Implementation methods for the integration of distributed systems: Template methodology (2013)
- ISO 15926/TS 8: Implementation methods for the integration of distributed systems: Web

- ISO 15926/TS 9: Implementation methods for the integration of distributed systems Façade implementation (Planned)
- ISO/TS 15926 10: *Conformance testing* (NP approved 2015)

- ISO 15926 12: Life cycle integration ontology represented in OWL (CD approved 2016)
- ISO 15926 13: Integrated planning for assets throughout their life-cycle (ILAP) (CD approved 2016)
- ISO 15926-5 has been replaced by ISO TC184/SC4: *Procedure for development and maintenance of reference data in database format*





- ISO 15926-12: Life cycle integration ontology was approved as an ISO project (NP) in January 2016
  - Active participation: China, France, Germany, Japan, Netherland, Norway and UK
  - Three year project
  - EPIM's ReportingHub and several other projects are based on early versions of ISO 15926-12
  - ISO 15926 13: Integrated planning for assets throughout their life-cycle (ILAP) has a normative reference to ISO 15926-12
- Committee Draft (CD) for ISO 15926-12 was approved in May 2016
  - Votes: 10 yes, 1 no, 5 abstaining and 1 yes after the ballot end

#### Current status

• All ballot comments resolved except Norwegian comments on the OWL DL profile





### ISO 15926-12 Approved plan

- DIS proposal to ISO by 30 November 2016
  - OWL Full and DL profile
  - For discussion:
    - DL profile normative or informative?
    - Remaining work and when can it be done?
  - Ballot results available by 31 May 2017?
- International Standard (IS) proposal by 31 August 2017
- All comments from ISO Central Secretariat resolved by 30 November 2017





- ISO 15926-12 without the OWL DL profile
  - DIS proposal can be sent to ISO by 30 November 2016
  - Reasoning limited
- ISO 15926-12 without the OWL DL profile as a TS
  - Committee internal ballot to change scope required (1 month ballot period)
  - Save time and money
  - Edition 2 of ISO 15926-2 is also being discussed. May be an ISO/TS 15926-12 is sufficient for now
- Propose the OWL DL profile as an ISO Technical Report?
- Propose the OWL DL profile as ISO 15926-14?
