Capital Facilities Information Handover Guide, Part 1

- Identify the **information requirements** of the selected processes
- Assess what is available in **structured data** formats
- Find out who is working on the development of **relevant standards** and the utility and maturity of these standards initiatives
- Define and execute a **plan** for industry-wide standards solutions for **information delivery and handover**

Interoperability:

the ability of two or more systems, components or processes to work together (inter-operate) and to **exchange information** and to **use the information that has been exchanged.**

Integration:

A process to **link** two or more previously separate systems or processes to become part of a larger system or process.

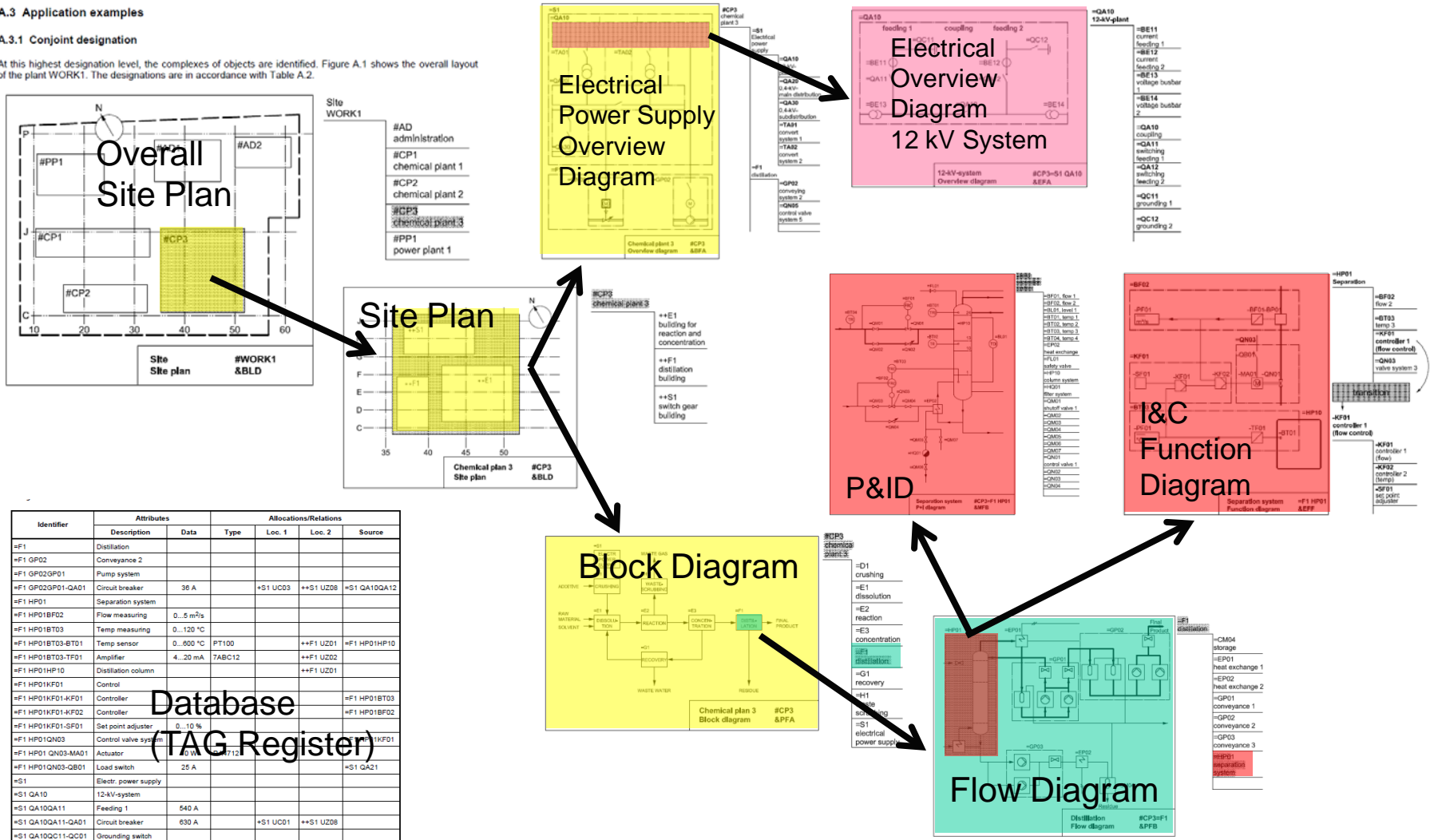

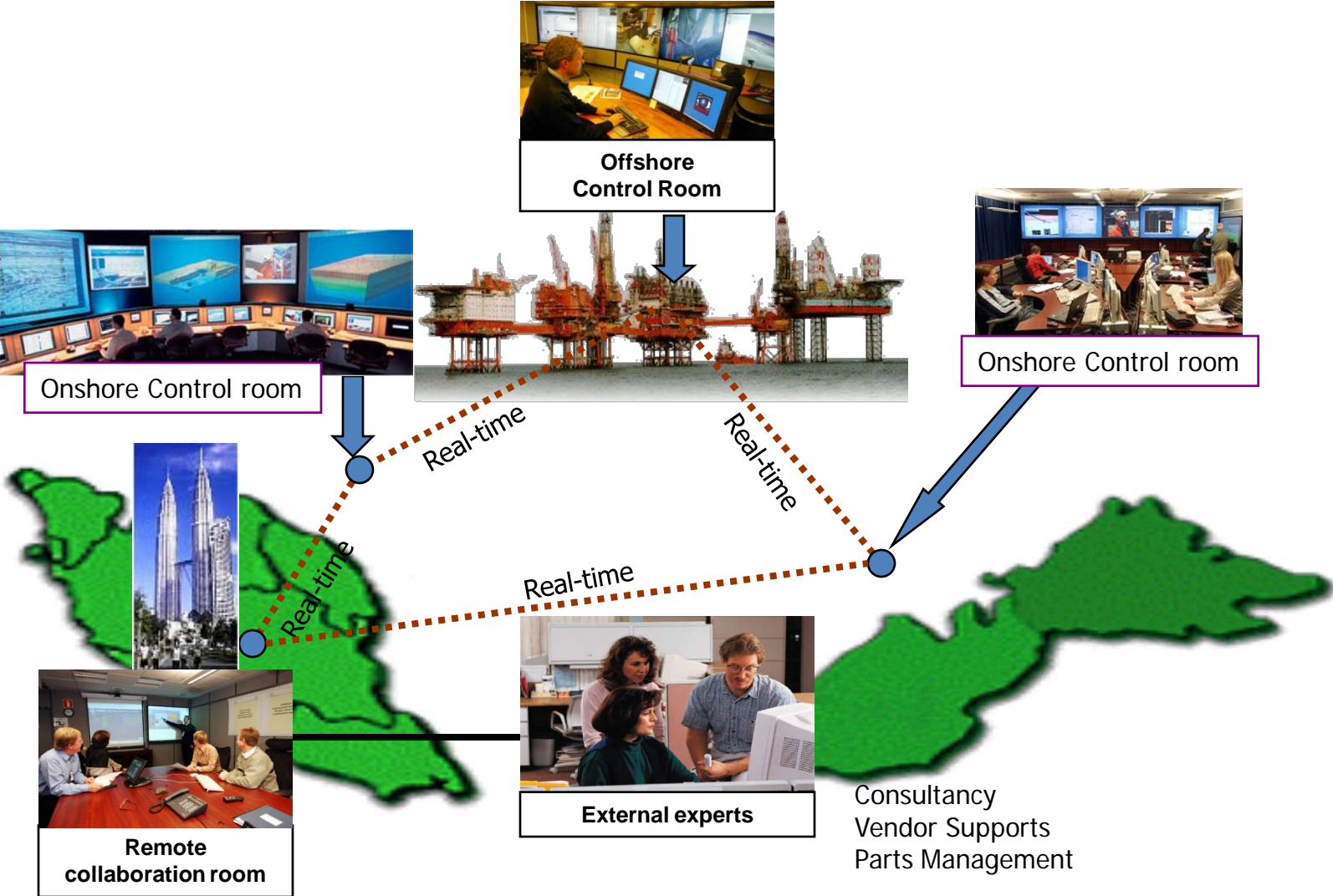
