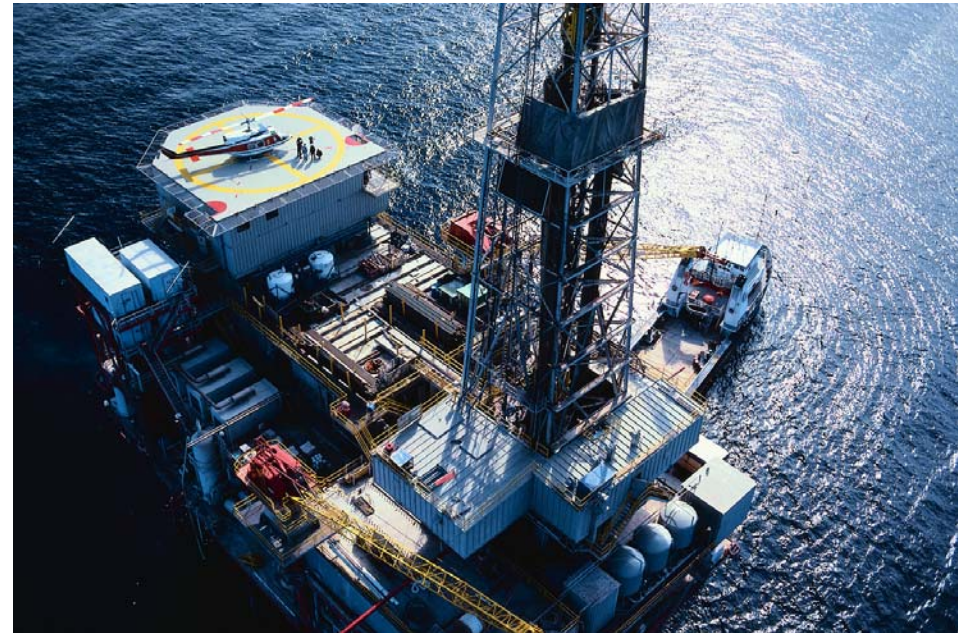

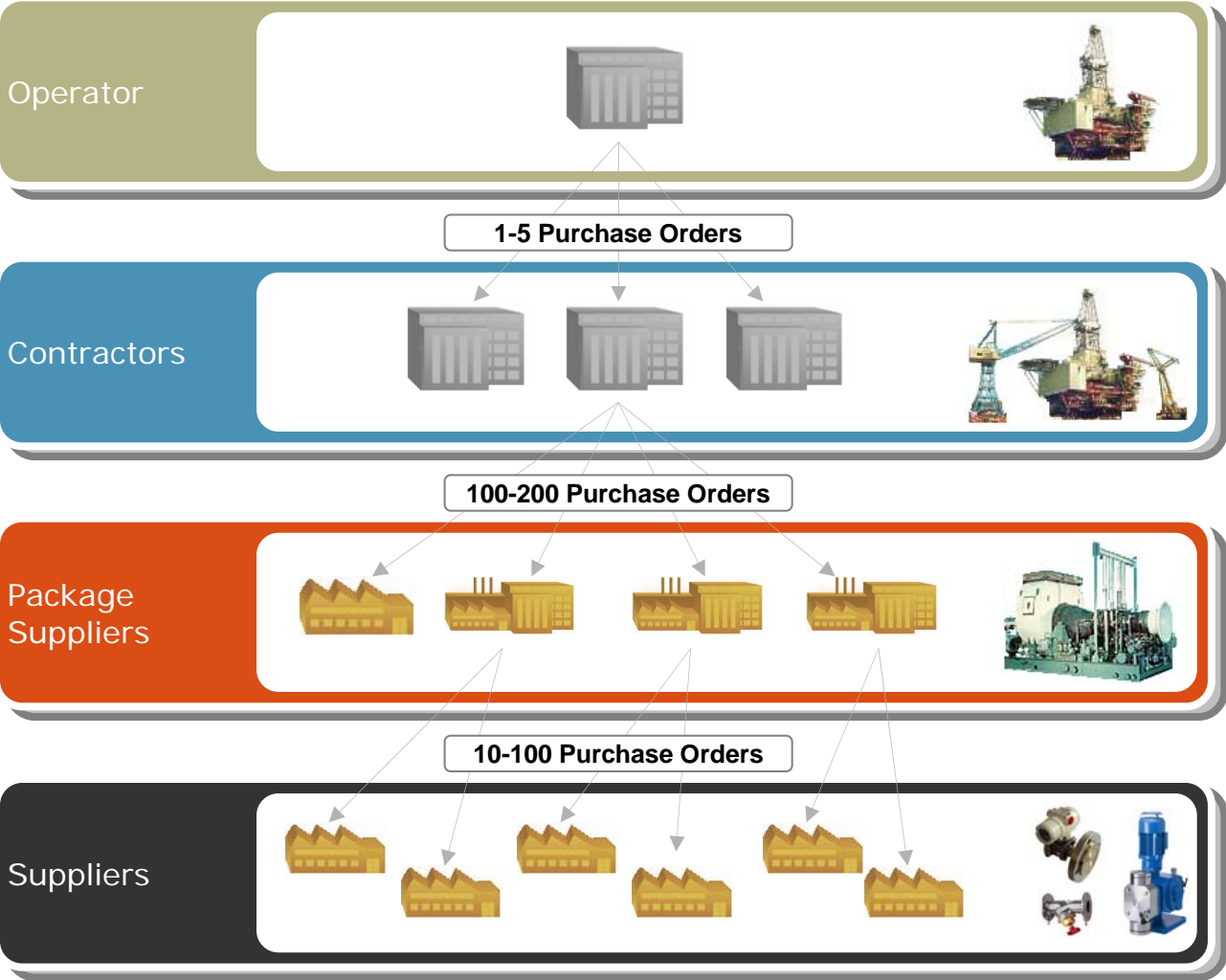
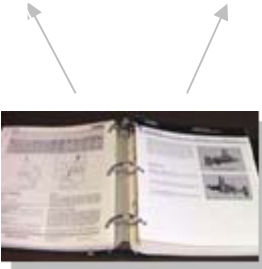
EPIM is supported administratively by OLF.

- * Mobilization February 2010

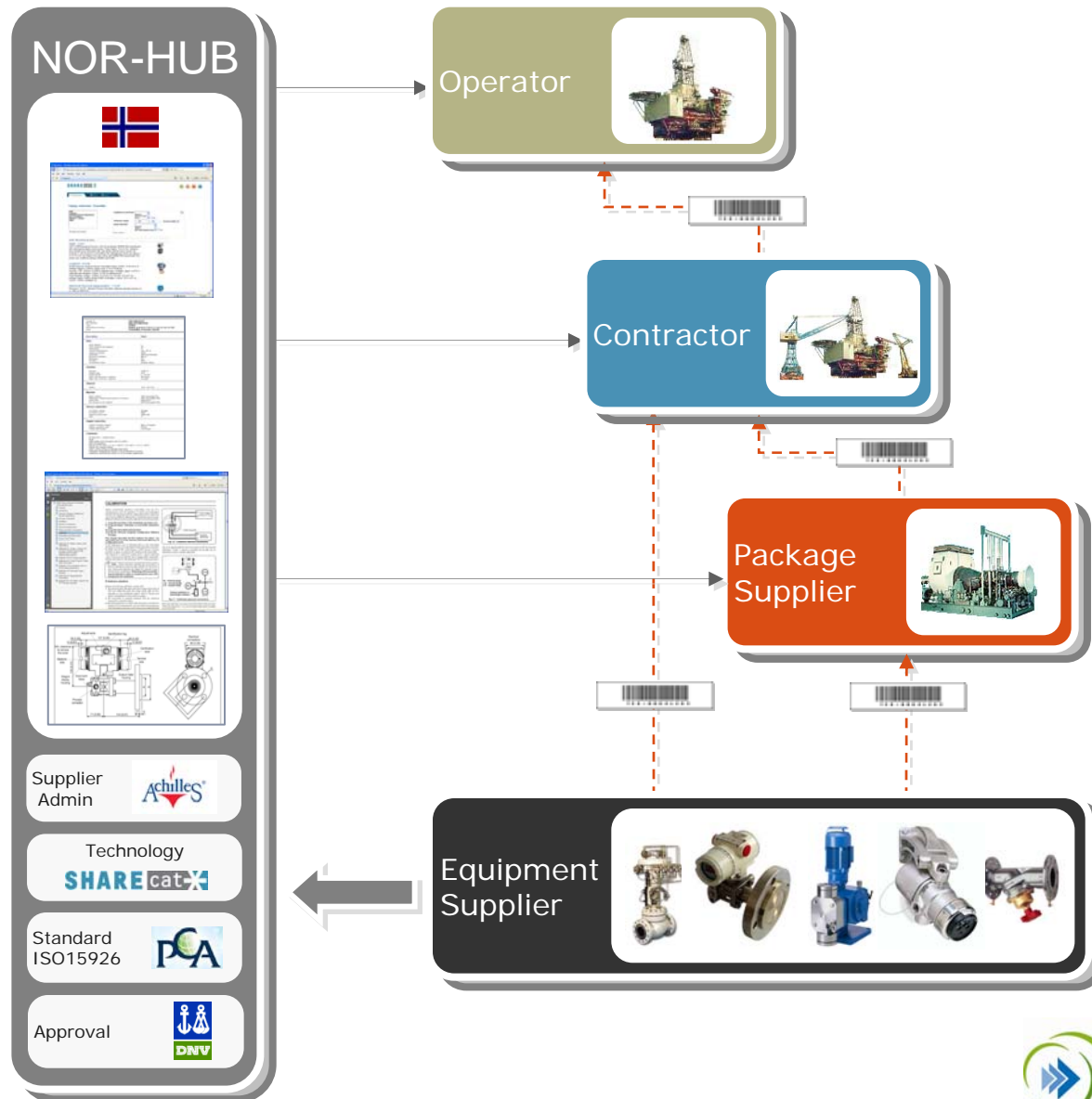
