

1. Mandate for Technical Advisory Board

PURPOSE

The Technical Advisory Board (TAB) shall work for the consistency and the quality of the POSC Caesar's Reference Data Library (RDL) and for making the total RDL completely compliant with the data model in ISO 15926 Part 2.

TASKS

The TAB is to safeguard and promote the process industry interests within the area of the RDL. The TAB's work must be based on POSC Caesar's Articles of Association and its strategies and main tasks, the methodology and principle of ISO 15926 and ISO Maintenance Agency. Furthermore, The TAB must be goal-oriented and result-oriented.

The TAB shall ensure that the process industry gets access to reference data of very high quality by contributing to:

- Making recommendation for further enhancement of ISO 15926 with respect to reference data
- Defining the quality levels WIP-A, WIP and ISO and establish guidelines for moving from one quality level to the next and maintain and enhance these documents
- Performing multi-discipline/multi-functional cross quality assurance between the domains of the SIGs every time the RDL is changed and/or enhanced to secure consistency and quality
- Establishing good dialogue arenas with all interested parties in the industry, in research and
 educational institutions and the authorities, and to clearly communicate the industry's
 position on key issues in this field

Organization

The TAB reports to the General Manager. A representative from POSC Caesar's membership and with acknowledge leadership within the ISO system is appointed as chairperson for the TAB. All chairpersons of the SIGs are members of the TAB. In addition, up to three (3) technically knowledgeable persons from the solution providers and up to three (3) persons technically knowledgeable persons from collaboration standardization organizations might be member of the TAB. The Tab ought to have a global representation as soon as possible.

The TAB shall have a least four (4) meetings per year. One meeting ought to be in person in connection with some major arrangement somewhere. The other meetings should be executed as efficient as possible using modern technology.

All work shall be conducted according to good business practices.

The General Manager shall see to that there is sufficient co-ordination between TAB and the SIGs and other ongoing activities within POSC Caesar and that the TAB activities conform to POSC Caesar's general policies and strategies.

By development of POSC Caesar statement or resolution, the TAB, ought to seek unanimously adoption. However, in such a way that individual member may make reservations and, if desirable, cite eventual deviating point of views to the statement or resolution.
