Discussion about the use of the staging endpoint and what happens when content is removed from the staging endpoint.

The reference data in the production endpoint will not be removed.

What happens at the end of the review window? The content will be copied into the production endpoint and will not be deleted from the staging endpoint.

Does the request require positive feedback before it moves into production?

- Possibly prompting users that about the proposal
- Or having a sign-off required by a minimum number of people

- Could be easier to try this out to see how it works and then handle any cases where there are no comments.

Notification process.

- Subscription of changes to the staging endpoint (and possibly the production endpoint)

Different approaches. The crowd-sourced vs. the authoritative model. Someone at PCA will also look at the proposal.

Finally there will be some black-out periods where new requests will not be taken. The whole of July, August and December.
